Labor, Health and Human Services, Education, and Related Agencies

Eliminate the Department of Education (p. 319)

Cuts the Department of Education by \$11 billion (14 percent)

Cuts Title I by \$4.7 billion — kicks 72,000 teachers out of classrooms

Eliminates English Language Acquisition—halting services for 5.5 million English learners

Slashes Federal Work Study in half—eliminating support for 330,000 students paying for college

Slashes need-based financial aid in half—eliminating need-based aid for 833,000 students

Eliminate Title I grants after 10 years (p. 326)

Cuts Title I by \$4.7 billion — kicks 72,000 teachers out of classrooms

Transportation, Housing and Urban Development, and Related Agencies

Reverse the 1968 bipartisan civil rights law (Fair Housing Act of 1968) which prohibits the use of taxpayer dollars from being used to discriminate against individuals and families seeking shelter, rental, and homeownership housing. Increase the upfront and annual cost of buying a home through the Federal Housing Administration (FHA). This new policy would make it much harder for mortgage-worthy families to purchase a home, access equity, and accrue wealth as they divert mortgages from public oversight to private banks with private interests. (p. 510)

Cuts fair housing enforcement and protections for vulnerable populations from discrimination by 2 percent, providing 85 million for Fair Housing and Equal Opportunity

Prohibits HUD from using funds to implement, administer, or enforce the “Affirmatively Furthering Fair Housing” rule to fulfill the requirements of the Fair Housing Act of 1968. This language would hamstring HUD’s ability to help its grantees comply with the long-standing civil rights law that protects housing rights of protected classes, which include race, color, national origin, religion, sex (including gender identity and sexual orientation), familial status, and disability.

Walk away from the 1964 labor protection laws for transit workers (Urban Mass Transportation Act) and **eliminate** Federal support for local transportation systems nationwide. This policy would keep our essential workers, including those in the service industry and teachers, as well as students and the elderly relying on paratransit and other local transportation services, in poverty and closed off from the larger economy and essential services needed to thrive and live independently. (p. 634)

Guts transit capital investment grants by 66 percent, and cuts Amtrak operations by more than 12 percent, resulting in service cuts, delays to station improvements that support accessibility for people with disabilities, and the loss of thousands of jobs

Commerce, Justice, Science, and Related Agencies

Cut taxes for billionaires and corporations (p. 696)

Cuts funding for DOJ's Tax Division by more than \$10 million, which will harm the government's ability to fully enforce the Nation's tax laws and ensure that the wealthy pay their fair share

Abolish the U.S. Economic Development Administration (EDA) (p. 683)

Cuts funding for EDA program grants by \$143.5 million. EDA grants help create jobs and economic opportunity, improve public infrastructure, and ultimately help revitalize communities facing decline and disinvestment throughout the Nation, particularly in rural areas

Financial Services and General Government

“Repeal Title I, Title II, and Title VIII of the Dodd-Frank Act” (p. 705)

“Repeal Dodd-Frank Section 1071” which aims to promote fair and transparent lending practices (p. 839)

Prohibits funds for Section 1071 of the Dodd-Frank Act, which requires the collection of data on lending to women and minority-owned businesses

“Reverse” Congress’ investments in the IRS that ensure billionaires and corporations pay their fair share (p. 699)

Cuts IRS by \$2.2 billion, decimating efforts to ensure wealthy individuals and corporations pay their taxes

Repeal the Corporate Transparency Act and command the Financial Crimes Enforcement Network (FinCEN) to withdraw its beneficial ownership reporting rule, which prevents criminals and terrorists from misusing companies to disguise their illicit activities and commit money laundering (p. 707)

Prohibits funding for FinCEN to implement or enforce the beneficial ownership reporting rules

Prohibit the SEC from requiring issuer disclosure of social, ideological, political, or “human capital” information that is not material to investors’ financial, economic, or pecuniary risks or returns (p. 832)

Prohibits the Securities and Exchange Commission (SEC) from using funds to finalize or enforce the proposed Climate Disclosure rule titled “The Enhancement and Standardization of Climate-Related Disclosures for Investors”

Terminate the Consolidated Audit Trail (CAT) program (p. 831)

Prohibits SEC from implementing the Consolidated Audit Trail

Military Construction, Veterans Affairs, and Related Agencies

Push for further privatization of VA Medical care (p. 644)

Makes wait time and drive time access standards only applicable to primary care, specialty care, and non-institutional extended care services

Agriculture, Rural Development, Food and Drug Administration, and Related Agencies

Reduce funds for ancillary and support operations at the Commodity Futures Trading Commission (CFTC) (p. 834)

Cuts the CFTC by \$20 million, which would harm CFTC’s ability to defend itself against cyberattacks that would devastate the global economy

Aims to Make Abortion Illegal Nationally

Trump's Project 2025 aims to restrict or ban access to abortion, fertility services, and contraception nationally. It erodes personal fundamental freedoms.

Labor, Health and Human Services, Education, and Related Agencies

Prohibit funding for Planned Parenthood health clinics (p. 471)

Prohibits funding for Planned Parenthood health clinics

Reimpose the Trump Administration's ban on Title X Family Planning grantees providing information on abortion (p. 455)

Prohibits Title X Family Planning grantees from providing information on abortion (which conflicts with Federal requirements to offer complete, medically accurate, comprehensive options counseling)

Reimpose the Trump Administration's ban on Title X Family Planning grantees referring for abortion services (p. 455)

Prohibits Title X Family Planning grantees from referring patients for abortion services (if the patient requests a referral) and prohibits Family Planning health clinics from providing counseling on abortion options in States that have banned abortion

Prohibit funding for women to travel to another State to access abortion services (p. 471)

Prohibits funding to assist women (located in States that have banned abortion) from accessing abortion services in other States

Cut Medicaid funding to States that require health insurance plans to offer coverage of abortion services (p. 471)

Amends the Public Health Service Act to allow an individual to sue in court, including for monetary damages, for a suspected violation of the Weldon amendment (which allows health care providers and health insurers to refuse to provide, or provide coverage of, abortions)

Prohibit funding to medical schools that offer abortion-related training on an opt-out basis (as opposed to an opt-in basis) (p. 786)

Prohibits funding to a hospital or post-graduate physician training program if the hospital or training program has an opt-out requirement for training related to abortion (as opposed to an opt-in requirement), which would result in fewer OB/GYNs receiving training to handle reproductive health care issues, including pregnancy-related emergencies and miscarriages

Prohibit biomedical research using fetal tissue (p. 460)

Prohibits funding to support life-saving biomedical research using fetal tissue if such tissue is obtained pursuant to an abortion

Reimpose the Trump Administration's ban on funding to Title X Family Planning grantees whose organizations provide abortion services Reframe the Title X Family Planning program around "fertility awareness" such as the rhythm method (p. 484)

Eliminates funding for Title X Family Planning services, including preventive health care services such as birth control and cancer screenings, for 2.6 million low-income women and men.

Agriculture, Rural Development, Food and Drug Administration, and Related Agencies

Reverse approval of mifepristone and abortion medication altogether; investigate abortion medication manufacturers; and stop approving new abortion medication (p. 458)

Restricts mifepristone's availability to make it more difficult for women to obtain reproductive healthcare, included in the 2024 House Republican bill and proposed in an amendment to the 2025 bill

Commerce, Justice, Science, and Related Agencies

Penalize low-income people seeking abortion — forcing those already struggling to make ends meet to pay the biggest proportion of her income for safe, legal care (p. 474)

Prohibits the Department of Justice (DOJ) from using funds to pay for abortions, except in cases of rape, incest, or danger to the life of the mother

Delete the terms... abortion, reproductive health, reproductive rights... out of every Federal rule, agency regulation, contract, grant, regulation, and piece of legislation that exists (p. 4 & 5)

Prohibits funds for DOJ's Reproductive Rights Task Force that monitors and evaluates all state and local legislation, regulations, and enforcement actions that (1) threaten to infringe on Federal legal protections related to reproductive care, (2) ban Mifepristone, (3) impair information about reproductive care in other states, or (4) impair reproductive care in states where it is legal

Prohibit the DOJ from pursuing lawsuits against states that are eliminating women's rights and access to abortion (p. 474)

Prohibits the use of funds to sue any State or local government over laws restricting abortion, or to intervene or file an amicus brief in such a case

Make it harder to report sexual harassment and assault. Ignore victims, protect perpetrators (p. 333)

Prohibits funds to finalize, implement, or enforce the Equal Employment Opportunity Commission's "Proposed Guidance on Harassment in the Workplace," or any similar guidance

Demand the Equal Employment Opportunity Commission (EEOC) ignore claims of employers' failure to accommodate employees seeking abortion care (p. 587)

Prohibits the implementation of the EEOC's April 2024 rule under the Pregnant Workers Fairness Act, so as to include elective abortion as a "related medical condition" of pregnancy requiring reasonable accommodation

Defense

End access to abortion for servicemembers (p. 104)

Prohibits implementation of the Department of Defense "Ensuring Access to Reproductive Health Care" memorandum that helps ensure servicemembers and their families are able to access reproductive health care

Military Construction, Veterans Affairs, and Related Agencies

"Rescind all departmental clinical policy directives that are contrary to principles of conservative governance starting with abortion services and gender reassignment surgery" (p. 644)

Prohibits the VA from implementing its interim final rule on abortions with limited exceptions-aimed to reduce veterans' access to abortions

State, Foreign Operations, and Related Programs

Expand the Global Gag Rule to all foreign assistance (p. 261)

Expands the Global Gag Rule for all global health programming

Remove all references to "gender," "reproductive health," and "sexual and reproductive rights" from the USAID website, publications, and agency contracts and grants (p. 259)

Removes all references to "gender" and prohibits funding for the Gender Equity and Equality Action Fund (GEEA)

Beyond the goal of making abortion illegal nationally, Project 2025's policy proposals will erode personal fundamental freedoms.

Starting on page 4, Trump's Project 2025 commands "deleting the terms sexual orientation and gender identity ("SOGI"), diversity, equity, and inclusion ("DEI"), gender, gender equality, gender equity, gender awareness, gender-sensitive, abortion, reproductive health, reproductive rights, and any other term used to deprive Americans of their First Amendment rights out of every federal rule, agency regulation, contract, grant, regulation, and piece of legislation that exists."

House Republicans are taking this directive seriously, banning even the slightest mention of diversity, equity, and inclusion and filling the 2025 funding bills with [more than 50 anti-equality, anti-LGBTQI+ policy provisions](#).

Erodes Checks and Balances

Trump's Project 2025 removes checks and balances to give the President more control over the government than at any time in American history. It advocates eliminating critical staff, giving the President the power to fire career civil servants, ending the independence of the FBI and DOJ, and making our elections less secure. And it calls for weakening our national security by isolating the United States from the rest of the world.

Commerce, Justice, Science, and Related Agencies

Undermine public-sector unions (p. 82)

Prohibits funds from being used for the operations or expenses of any Federal employee union

Shrink FBI headquarters (p. 551)

Cuts the FBI Salaries and Expenses account by \$367.7 million below 2024, which would result in thousands fewer FBI employees, across both headquarters and the FBI field offices

Prohibits funds for DOJ to implement or administer the relocation of FBI's crumbling headquarters building on Pennsylvania Avenue

Prohibit the FBI from combating the spread of misinformation and disinformation (p. 550)

Prohibits the FBI's Foreign Influence Task Force from monitoring or labeling constitutionally protected speech by anyone in the U.S. as mis-, dis-, or mal-information

Prohibits the classification of any communications by any person in the U.S. as mis-, dis-, or mal-information or to partner with any entity to censor lawful and constitutionally protected speech of United States persons

Limit the DOJ's ability to protect Americans' Civil Rights and promote equity (p. 561)

Cuts DOJ's Civil Rights Division by \$35 million, which will greatly harm civil rights enforcement

Limit the DOJ's independence and ensure the DOJ and FBI's loyalty to the President (Chapter 17)

Cuts funding for DOJ's Office of Legal Counsel by \$3.3 million (29 percent). Among the important roles of DOJ's Office of Legal Counsel is to review all executive orders and substantive proclamations for legality if the President proposes them, as well as to review and comment on the constitutionality of pending legislation

Financial Services and General Government

Stop the U.S. Small Business Administration from expanding citizens' opportunities to register to vote (p. 749)

Prohibits the implementation of the Executive Order on Promoting Access to Voting with certain exceptions, making it more difficult for people to vote

Prohibit the FBI from engaging, in general, in activities related to combating the spread of so-called misinformation and disinformation by Americans who are not tied to any plausible criminal activity (p. 550)

Prohibits the government from contracting with, granting awards to, or otherwise obligating or expending funds to entities under the stated function of "fact-checking", or otherwise exposing or correcting mis-information, dis-information, or mal-information

State, Foreign Operations, and Related Programs

Restrict funds to the World Health Organization and other health-focused international organizations (p. 192)

Prohibits funding for the WHO and all international treaties, agreements, or any international alliance with legal force until ratified by the Senate

Make deep cuts in the international affairs budget (p. 254)

Slashes funds for development aid and State Department and USAID operations by \$7 billion (12 percent)

Withdrawal from many international organizations. "The next Administration should direct the Secretary of State to initiate a comprehensive cost-benefit analysis of U.S. participation in all international organizations" (p. 191)

Eliminates funding for the United Nations Regular Budget, and the International Organization and Programs like UNICEF, UNDP.

Cut aid to states ... such as Iraq, Lebanon, and the Palestinian territories (p. 274)

Defunds the Office of Palestinian Affairs, takes a punitive approach to any assistance for West Bank and Gaza, and prohibits assistance to Iraq

Homeland Security

Halt funds given to nongovernmental organizations (NGOs) to process and transport migrants into and throughout the United States (p. 149)

Eliminates the Shelter and Services Program and includes language to prohibit the use of funds to transport noncitizens into the interior of the U.S., with a limited exception for enforcement of immigration laws – adding to logistical challenges of mitigating overcrowded facilities along the border

Immediately end CISA's counter-mis/disinformation efforts (p. 155)

Limits the Department's ability to counter disinformation campaigns, including from malign

foreign actors who seek to undermine our democratic elections and limits DHS's ability to counter mis-, dis-, or mal-information efforts by domestic extremists and other adversaries who seek to cause harm to our critical infrastructure and our communities

Eliminate the Office of the Immigration Detention Ombudsman (p. 165)

Eliminates funding for OIDO, a key office for oversight of immigration facilities

Military Construction, Veterans Affairs, and Related Agencies

Transfer all career senior executives out of appointed and confirmed positions on the first day and "ensure political control of the VA" (p. 651)

Prohibits VA from using critical incentive skill payments to recruit or retain experts

Agriculture, Rural Development, Food and Drug Administration, and Related Agencies

"Make deep cuts in the International Development Association (IDA) budget," the government's primary humanitarian aid funding source (p. 268)

Cuts \$688 million from Food for Peace, which would be the lowest level since 2002. This cut would harm American farmers, increase hunger around the world, and threaten our national security

Ends All Efforts to Confront the Climate Crisis

Trump's Project 2025 aims to end all efforts to address damage to our climate, curb pollution, and transition to clean energy.

Interior, Environment, and Related Agencies

Eliminate the Office of Environmental Justice and External Civil Rights (p. 421)

Defunds Environmental Justice activities at the EPA

Reverse the Biden Administration's efforts to confront the climate crisis (p. 60)

Prohibits funds for 31 EPA regulations

Reinstate the Trump-era Energy Dominance Agenda, rescind Secretarial Order (SO) 3398 and reinstate the Trump DOI secretarial orders regarding coal,

Abandons withdrawal of lands from leasing in protected areas, does not ensure fair return from leasing on public lands for American taxpayers and prohibits updating leasing regulations

Commerce, Justice, Science, and Related Agencies

Deny the facts and science displayed in the U.S. Global Change Research Program assessment (p. 60 & 439)

Blocks the National Science Foundation from funding the U.S. Global Change Research Program

Prevent the government from responding to the climate crisis (p. 60)

Prohibits funding to enforce Executive Order 14008 (Jan. 27, 2021), entitled "Tackling the Climate Crisis at Home and Abroad." Also blocks funding for the NIST Center of Excellence in Climate Change, NSF's Clean Energy Technology Program, and climate change fisheries research funded by the Commerce Department

Prohibits funding for implementation of Executive Order 14072, relating to the valuation of ecosystem and environmental services and natural assets in Federal regulatory decision-making

Cuts DOJ's Environment and Natural Resources Division by \$21.9 million, which will harm DOJ's ability to bring cases against those who violate the nation's environmental laws

Prevent NOAA from researching and warning the world about the dangers of the climate crisis (p. 676)

Cuts overall NOAA Climate Research funding by \$68 million

State, Foreign Operations, and Related Programs

Rescind all climate policies from foreign aid programs and shut down offices, programs, and directives designed to advance the Paris Agreement. Cease collaboration with organizations that advocate "climate fanaticism" (p. 257)

Prohibits all funding to advance the Paris Agreement, removes all funding directed toward climate goals, prohibits the Green Climate Fund, loss and damage

Agriculture, Rural Development, Food and Drug Administration, and Related Agencies

Restrict the Secretary of Agriculture's ability to use funds from the Commodity Credit Corporation (CCC) and create grounds to challenge CCC usage in court, shifting policymaking to extreme, conservative judges (p. 294)

Restricts the Secretary of Agriculture's ability to use funds from the Commodity Credit Corporation (CCC), which would prevent USDA from responding to natural disasters and other threats to American agriculture fueled by climate change

Financial Services and General Government

Reverse support for efforts promoting Environmental, Social, and Governance and Principles for Responsible Investment, both of which have badly damaged U.S. energy security (p. 709)

Prohibits funds from being used to establish a Federal Advisory Committee based on Environmental, Social, or Governance aspects in the United States
Department of Treasury

End federal mandates and subsidies of electric vehicles (p. 537)

Prevents procurement of electric vehicles, electric vehicle batteries, electric vehicle charging stations or infrastructure
