## CONCURRENT RESOLUTION

Establishing the congressional budget for the United States Government for fiscal year 2025 and setting forth the appropriate budgetary levels for fiscal years 2026 through 2034.

1        *Resolved by the House of Representatives (the Senate*  
2        *concurring),*

3        **SECTION 1. CONCURRENT RESOLUTION ON THE BUDGET**  
4        **FOR FISCAL YEAR 2025.**

5        (a) DECLARATION.—The Congress determines and  
6        declares that prior concurrent resolutions on the budget  
7        are replaced as of fiscal year 2025 and that this concur-  
8        rent resolution establishes the budget for fiscal year 2025  
9        and sets forth the appropriate budgetary levels for fiscal  
10       years 2026 through 2034.

15 reforms, or other measures deemed appropriate by the  
16 chair of the Committee on the Budget of the House.

17           (e) CONSISTENCY WITH THE RESOLUTION.—Any  
18 reconciliation recommendations receiving an allocation ad-  
19 justment under this section shall not be considered in vio-  
20 lation of the budgetary levels established by this concur-  
21 rent resolution.

## 22 **TITLE IV—POLICY STATEMENTS**

### 23 **SEC. 4001. POLICY STATEMENT ON ECONOMIC GROWTH.**

24           (a) FINDINGS.—The House finds the following:

1           (1) The rate of economic growth has a signifi-  
2           cant impact on budget deficits. When the rate of  
3           gross domestic product (GDP) increases, projected  
4           revenue grows with it and deficits decline. Con-  
5           versely, slower GDP growth can lead to lagging reve-  
6           nues and mounting deficits.

7           (2) Federal policies affect the economy’s poten-  
8           tial to grow and impact economic performance, influ-  
9           encing budgetary outcomes. Consequently, fiscally  
10          responsible policies that improve the economy’s long-  
11          term growth prospects help reduce the size of budget  
12          deficits over a given period.

13          (3) The free market, where individuals pursue  
14          their own self-interests, has been responsible for  
15          greater advancements in quality of life and genera-  
16          tion of wealth than any other form of economic sys-  
17          tem. Federal policies designed to grow the economy  
18          should thus allow market forces to operate  
19          unhindered rather than pick “winners” and “losers”.

20          (b) POLICY ON ECONOMIC GROWTH.—It is the policy  
21          of this concurrent resolution to pursue policies that em-  
22          brace the free market and promote economic growth poli-  
23          cies that—

24                  (1) reduce Federal spending;

25                  (2) expand American energy production;

1           (3) lower taxes that discourage work, savings,  
2           and investment;

3           (4) deregulate the economy and enact reforms  
4           to diminish bureaucratic red tape; and

5           (5) eliminate barriers to work so more Ameri-  
6           cans enter (or reenter) the job market.

7 **SEC. 4002. POLICY STATEMENT ON MANDATORY SPENDING**

8           **REDUCTION.**

9           (a) FINDINGS.—The House finds the following:

10           (1) The United States faces a significant debt  
11           crisis, with the national debt currently exceeding  
12           \$36 trillion, or 123 percent of GDP.

13           (2) Since 2019, mandatory spending has in-  
14           creased by 59 percent.

15           (3) This debt poses a significant risk to the  
16           country’s long-term fiscal sustainability, with impli-  
17           cations for future generations.

18           (4) Mandatory spending currently accounts for  
19           over 70 percent of the entire Federal budget.

20           (5) The deficit for fiscal year 2025 is projected  
21           to be \$1.9 trillion, or 6.2 percent of GDP.

22           (6) This fiscal year, net interest will total \$952  
23           billion, or 3.2 percent of GDP.

24           (b) POLICY ON MANDATORY SPENDING REDUC-  
25           TION.—It is the goal of this concurrent resolution to re-

1 duce mandatory spending by \$2 trillion over the budget  
2 window. If the combined deficit reduction provided by au-  
3 thorizing committees is below this target, it is the policy  
4 of the Committee on the Budget of the House that the  
5 instruction provided to the Committee on Ways and Means  
6 of the House should be reduced by a commensurate  
7 amount to offset the difference.

8 **SEC. 4003. POLICY STATEMENT ON GOVERNMENT DEREGU-**  
9 **LATION.**

10 (a) FINDINGS.—The House finds the following:

11 (1) Regulations throughout the Federal Govern-  
12 ment have been a major issue for decades, continu-  
13 ously growing while negatively impacting the na-  
14 tion's economic and fiscal standing.

15 (2) Overregulation has consistently hurt small  
16 businesses, strangled domestic energy production,  
17 weakened labor market conditions, and expanded  
18 government overreach and costs on taxpayers.

19 (3) Real (inflation-adjusted) spending on regu-  
20 latory agencies has increased exponentially since  
21 1960. The total number of pages in the Code of  
22 Federal Regulations (CFR) has increased from  
23 22,877 pages in 1960 to nearly 200,000 today.  
24 When compared to 1950, the CFR contained only

1 9,745 pages in 1950, making the size of the CFR  
 2 today 95% larger than it was in 1950.

3 (b) POLICY STATEMENT ON GOVERNMENT DEREGU-  
 4 LATION.—It is the policy of this concurrent resolution—

5 (1) that Congress continues to examine ways to  
 6 relieve the burdens of overregulation throughout the  
 7 Federal Government;

8 (2) that Congress is ready to promote initiatives  
 9 that will reduce government bureaucracy, enhance  
 10 Federalism, and increase economic prosperity  
 11 through deregulation;

12 (3) to not only reduce burdensome, costly regu-  
 13 lations, but to also reassert the role of Congress; and

14 (4) to enact legislation through reconciliation  
 15 that strengthens Congress, scales back Federal regu-  
 16 lations, limits future bureaucratic red tape, and  
 17 unleashes economic growth, such as the Regulations  
 18 from the Executive in Need of Scrutiny (REINS)  
 19 Act.

## 20 **TITLE V—OTHER MATTERS**

### 21 **SEC. 5001. ENFORCEMENT FILING IN THE HOUSE OF REP-** 22 **RESENTATIVES.**

23 In the House of Representatives, if a concurrent reso-  
 24 lution on the budget for fiscal year 2025 is adopted with-  
 25 out the appointment of a committee of conference on the

1 disagreeing votes of the two Houses with respect to this  
2 concurrent resolution on the budget, for the purpose of  
3 enforcing the Congressional Budget Act of 1974 (2 U.S.C.  
4 621 et seq.) and applicable rules and requirements set  
5 forth in the concurrent resolution on the budget, the allo-  
6 cations provided for in this section shall apply in the  
7 House of Representatives in the same manner as if such  
8 allocations were in a joint explanatory statement accom-  
9 panying a conference report on the budget for fiscal year  
10 2025. The chair of the Committee on the Budget of the  
11 House of Representatives shall submit a statement for  
12 publication in the Congressional Record containing—

13           (1) for the Committee on Appropriations, com-  
14           mittee allocations for fiscal year 2025 consistent  
15           with title I for the purpose of enforcing section 302  
16           of the Congressional Budget Act of 1974 (2 U.S.C.  
17           633); and

18           (2) for all committees other than the Com-  
19           mittee on Appropriations, committee allocations con-  
20           sistent with title I for fiscal year 2025 and for the  
21           period of fiscal years 2025 through 2034 for the  
22           purpose of enforcing section 302 of the Congres-  
23           sional Budget Act of 1974 (2 U.S.C. 633).

1 **SEC. 5002. BUDGETARY TREATMENT OF ADMINISTRATIVE**  
2 **EXPENSES IN THE HOUSE OF REPRESENTA-**  
3 **TIVES.**

4 (a) **IN GENERAL.**—In the House of Representatives,  
5 notwithstanding section 302(a)(1) of the Congressional  
6 Budget Act of 1974 (2 U.S.C. 633(a)(1)), section 13301  
7 of the Budget Enforcement Act of 1990 (2 U.S.C. 632  
8 note), and section 2009a of title 39, United States Code,  
9 the report or the joint explanatory statement accom-  
10 panying this concurrent resolution on the budget or the  
11 statement filed pursuant to section 5001, as applicable,  
12 shall include in an allocation under section 302(a) of the  
13 Congressional Budget Act of 1974 (2 U.S.C. 633(a)) to  
14 the Committee on Appropriations of the House of Rep-  
15 resentatives amounts for the discretionary administrative  
16 expenses of the Social Security Administration and the  
17 United States Postal Service.

18 (b) **SPECIAL RULE.**—In the House of Representa-  
19 tives, for purposes of enforcing section 302(f) of the Con-  
20 gressional Budget Act of 1974 (2 U.S.C. 633(f)), esti-  
21 mates of the level of total new budget authority and total  
22 outlays provided by a measure shall include any discre-  
23 tionary amounts described in subsection (a).

1 **SEC. 5003. APPLICATION AND EFFECT OF CHANGES IN AL-**  
2 **LOCATIONS, AGGREGATES, AND OTHER**  
3 **BUDGETARY LEVELS.**

4 (a) APPLICATION.—Any adjustments of allocations,  
5 aggregates, and other budgetary levels made pursuant to  
6 this concurrent resolution shall—

7 (1) apply while that measure is under consider-  
8 ation;

9 (2) take effect upon the enactment of that  
10 measure; and

11 (3) be published in the Congressional Record as  
12 soon as practicable.

13 (b) EFFECT OF CHANGED ALLOCATIONS, AGGRE-  
14 GATES, AND OTHER BUDGETARY LEVELS.—Revised allo-  
15 cations, aggregates, and other budgetary levels resulting  
16 from these adjustments shall be considered for the pur-  
17 poses of the Congressional Budget Act of 1974 (2 U.S.C.  
18 621 et seq.) as the allocations, aggregates, and other  
19 budgetary levels contained in this concurrent resolution.

20 (c) BUDGET COMMITTEE DETERMINATIONS.—For  
21 purposes of this concurrent resolution, the levels of new  
22 budget authority, outlays, direct spending, new entitle-  
23 ment authority, revenues, deficits, and surpluses for a fis-  
24 cal year or period of fiscal years shall be determined on  
25 the basis of estimates made by the chair of the Committee  
26 on the Budget of the applicable House of Congress.

1 (d) AGGREGATES, ALLOCATIONS AND APPLICA-  
2 TION.—In the House of Representatives, for purposes of  
3 this concurrent resolution and budget enforcement, the  
4 consideration of any bill or joint resolution, or amendment  
5 thereto or conference report thereon, for which the chair  
6 of the Committee on the Budget makes adjustments or  
7 revisions in the allocations, aggregates, and other budg-  
8 etary levels of this concurrent resolution shall not be sub-  
9 ject to the point of order set forth in clause 10 of rule  
10 XXI of the Rules of the House of Representatives.

11 **SEC. 5004. ADJUSTMENTS TO REFLECT CHANGES IN CON-**  
12 **CEPTS AND DEFINITIONS IN THE HOUSE OF**  
13 **REPRESENTATIVES.**

14 In the House of Representatives, the chair of the  
15 Committee on the Budget may adjust the appropriate ag-  
16 gregates, allocations, and other budgetary levels in this  
17 concurrent resolution for any change in budgetary con-  
18 cepts and definitions consistent with section 251(b)(1) of  
19 the Balanced Budget and Emergency Deficit Control Act  
20 of 1985 (2 U.S.C. 901(b)(1)).

21 **SEC. 5005. ADJUSTMENT FOR CHANGES IN THE BASELINE.**

22 In the House of Representatives, the chair of the  
23 Committee on the Budget may adjust the allocations, ag-  
24 gregates, and other appropriate budgetary levels in this  
25 concurrent resolution to reflect changes resulting from the

1 Congressional Budget Office’s updates to its baseline for  
2 fiscal years 2025 through 2034.

3 **SEC. 5006. EXERCISE OF RULEMAKING POWERS.**

4 Congress adopts the provisions of this title—

5 (1) as an exercise of the rulemaking power of  
6 the Senate and the House of Representatives, re-  
7 spectively, and as such they shall be considered as  
8 part of the rules of each House or of that House to  
9 which they specifically apply, and such rules shall  
10 supersede other rules only to the extent that they  
11 are inconsistent with such other rules; and

12 (2) with full recognition of the constitutional  
13 right of either the Senate or the House of Rep-  
14 resentatives to change those rules (insofar as they  
15 relate to that House) at any time, in the same man-  
16 ner, and to the same extent as is the case of any  
17 other rule of the Senate or House of Representa-  
18 tives.
